# **Privacy Policy**

# Introduction

Children Action respects the confidentiality of personal data.

This Confidentiality Policy explains:

- a) which information is collected when you access and use the Internet pages accessible at <a href="http://www.childrenaction.org">http://www.childrenaction.org</a> ("the Website");
- b) how we use the information collected ;
- c) the level of security we provide to protect this information.

By accessing and using the Website, you accept this Confidentiality Policy. The policy may be modified at any time to take into account new commercial or technological practices or legislative modifications.

# **Data collection**

We collect data in connection with your access to and use of **the Website**. In particular, we may collect personal data such as your name, sex, date of birth, address, payment information, e-mail address, telephone number, language preference, profession and any other information that may be used to identify or contact you in connection with your access to and use of the Website ("**Personal Data**").

# Use of collected data

Data that have been collected and transmitted are used for the purposes mentioned at the time of collection, which include performing activities and furthering our humanitarian goals. In particular, we use these data to communicate targeted information concerning our activities, financial support (including support for our projects and actions) and subscriptions to an electronic newsletter. Children Action respects your desire not to be contacted when receiving *an express request from you at children@childrenaction.org*.

# **Right of access and modification**

Unless otherwise required by law, we will provide you with a summary of data collected and processed on request. Subject to any contrary legal provisions, you will be given the opportunity to correct, update, modify or delete this information by sending a request by E-mail to <u>children@childrenaction.org</u>.

# **Communication to third parties**

We do not communicate your **Personal Data** to third parties, except to our partners and/or subcontractors when this is necessary to perform the goals for which data were collected.

## International transmission

Children Action refrains from processing, hosting or transferring the information collected to a country located outside the European Union or recognized as "unsuitable" by the European Commission without first informing you.

## **Third-party websites**

**The Website** may contain links or referrals to other third-party websites, including partners' websites that are directly managed and supervised by them. This Confidentiality Policy does not apply to these third-party websites or to the practices of other companies or individuals that Children Action does not control. You must find out and review the confidentiality policies of third-party websites that you visit, as these policies govern the collection and use of your **Personal Data** when you visit these websites. Subject to legal limits, Children Action cannot be held liable for the confidentiality practices of third-party websites.

# **Cookies**

To improve the uses and features of our Services, we use "cookies" or other beacons that may automatically save **Personal Data**. A cookie is a small data file that is saved on your electronic device. When you access and use **the Website**, the cookie identifies your electronic device. We also use cookies to measure **the Website**'s traffic, use and features.

If you do not want cookies to be saved on your electronic device, you must configure your Internet browser or electronic device to refuse cookies before using **the Website**. If you do not do so, you consent to the collection and processing of the data collected. This may affect or prevent your use of **the Website** or some of its features.

### **Modifications**

We may modify this Confidentiality Policy at any time as we see fit. By accessing and using **the Website** after these modifications, you accept the modified Confidentiality Policy. The Confidentiality Policy in force when data is collected and used governs the collection and use of this data.

### Applicable law and place of jurisdiction

This Confidentiality Policy is subject to Swiss substantive law, except its conflict-of-law rules.

Any complaint, claim or dispute must be filed with the competent courts for Children Action, subject to any appeal filed with the Swiss Federal Supreme Court.
